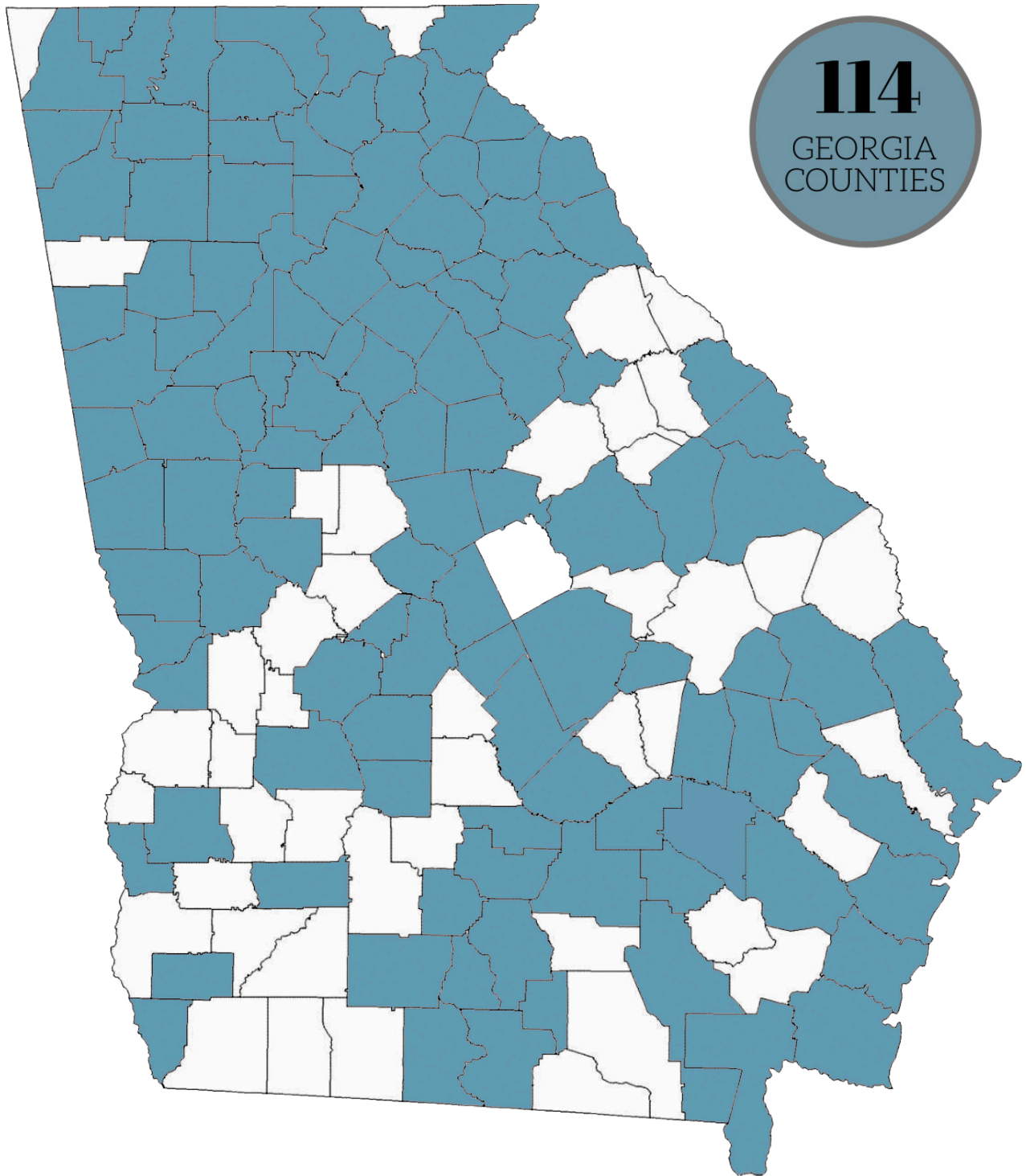

A SNAPSHOT OF RESULTS

- **Secured** one of the largest 7-figure confidential settlements in Georgia against a national nursing home chain.
- **\$1.8 million** verdict for the family of an elderly nursing home resident who died after hitting her head during a bed linen change.
- **Secured** the largest nursing home arbitration award in the State of Georgia.
- **\$975,000** for the wrongful death of a patient who developed a subclavian port infection.
- **\$950,000** for the wrongful death of a nursing home resident who fell.
- **\$617,000** for elder abuse that resulted in comminuted fractures of the victim's legs, and eventual death.
- **\$600,000**- A nursing home's negligence led to unacceptable conditions, dehydration, malnutrition, significant breakdown of skin, stage IV decubitus ulcers, and the resident's untimely and tragic death.
- **\$550,000** for a nursing home resident who suffered decubitus ulcers.
- **\$510,000** for a nursing home resident who was held down against her will and injured.
- **\$500,000** for the family of an elderly nursing home resident who received the wrong medication that led to pain, suffering, and death.
- **\$450,000** for a 97 year old resident who fell and suffered a subdural hematoma.

Elder abuse can occur at hospitals, nursing homes, memory care centers, assisted living facilities, personal care homes, adult day health centers, respite care, home health services, hospice, and VA medical centers.

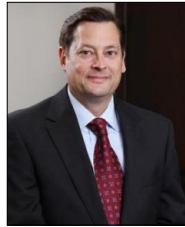
