A rape occurred after an office building janitor was hired despite his background check showing an extensive criminal history of assaults.

A disabled man suffered 2nd- and 3rd-degree burns caused by a hot water heater set at dangerously high temperatures. The defendant was a local governmental housing authority in a conservative, rural county.

A back injury case when trains collided and the engineer was injured.

Verdict for a survivor. A rape occurred after an apartment complex did not warn tenants of prior crimes at the complex, despite being told to do so by police.


