## **81% of Atlanta-Area Nursing Homes Receive 3-Star Rating or Less**

**ATHENS, Ga. – (May 8, 2024)** – The American Health Care Association has designated May 12-18 as National Skilled Nursing Care Week. Formerly known as National Nursing Home Week, this week aims to highlight the role of skilled nursing care in nursing homes and long-term care facilities across the country.

In recognition, Georgia law firm [Blasingame, Burch, Garrard & Ashley, P.C.](#) (BBGA), which specializes in nursing home abuse and neglect cases, has compiled a list of the best- and worst-rated nursing homes in the Atlanta region. The list is based on ratings from The Centers for Medicare & Medicaid Services (CMS).

There are 64 Medicare- and Medicaid-certified nursing homes within a 25-mile radius of Atlanta. Of those 64 facilities, only five received a five-star rating and 25 received a one-star rating. Seven received a four-star rating, five received a three-star rating, and 22 a two-star rating. This means that 81% of Atlanta-area nursing homes received a three or below rating while 39% received just one star. Seven of the facilities have been cited for abuse and two are included on the [Special Focus Facility list \(SFF\)](#).

CMS rates Medicare- and Medicaid-certified nursing homes based on their health inspection status, quality of resident care measures, and staffing. Ratings are updated annually in April, and facilities are given an overall star rating from one to five stars. A one-star rating is considered “much below average,” and a five-star rating is “much above average.”

“The federal government has standards of care in place to ensure certified nursing homes give residents the best possible care,” said BBGA Nursing Home Abuse Attorney Evan Jones. “Unfortunately, more and more Georgia facilities are falling short of meeting these standards. When this happens, it’s the residents who suffer – often catastrophically. Shining a light on the CMS ratings will hopefully help families determine which facility is the best choice for their loved one.”

BBGA lists all five-star (Best) and one-star (Worst) ratings within a 25-mile radius of Atlanta. The CMS data was last updated on April 24. [Click here more information.](#)
